



Hong Kong Scout Centenary Jamboree

Introduction

To celebrate the Centenary of Hong Kong Scouting in 2011, a series of activities are scheduled to be organized. One of the large scale events is the “Hong Kong Scout Centenary Jamboree” which will be held at Penny’s Bay next to the Hong Kong Disneyland on Lantau Island.

Overseas National Scout Organizations and youth organizations in the Mainland will be invited to send their contingents to participate in the Jamboree. They will be allocated into 5 Sub-Camps to share experience with Hong Kong Scouts.

Duration

27 December 2010 (Monday) – 1 January 2011 (Saturday)

Venue

Penny’s Bay (next to the Hong Kong Disneyland on Lantau Island) (tentative)

Organization

Apart from the Jamboree Headquarters, there will be 5 Sub-Camps, supported by essential functional camp committees. Names and colours of the Sub-Camps will be announced at a later stage.

Eligibility

Campers of the Jamboree must be Scouts, Venture Scouts or Rover Scouts fulfilling all of the following criteria:

1. Aged between 12 and 26;
2. Campers who are under the age of 18, their parents’ or guardians’ approval must be sought;
3. Recommended by Group Scout Leader / Scouter-in-charge; and
4. The ratio of adult leader to youth member is 1: 9 (The ratio of 1: 9 does not apply to Rover Scouts. If no Rover Scout leader is available to take up the duty as a leader in the camp, Rover Scouts may submit their Registration Forms to their respective *Regions with support from Group Scout Leader / Scouter-in-charge.)



Registration

Duly completed Registration Form should be submitted to respective *Regional Headquarters. Please refer to the "Registration Procedure" for details.

Camp Fee

The camp fee is HK\$600 per person, which include the provision of regular meals during the Jamboree period, general insurance coverage, name tag, camper handbook, Jamboree emblem, cap, scarf and certificate of participation only. Participants not staying for the whole duration of the Jamboree are still required to pay full fee.

Registration Deadline

1st Batch : 15 July 2010
2nd Batch : 15 October 2010

Early Bird Souvenir Badge for 1st Batch Registration

Applicants who enroll before the deadline of the 1st Batch of registration will get an early bird souvenir badge, which would form a special pattern with the Jamboree emblem.

Subsidy Scheme

Subsidies would be offered to Scouts, Venture Scouts or Rover Scouts aged between 12 and 26 who are eligible for financial assistance. Details of such subsidy are stipulated in Jamboree Circular No. 02/2010.

Equipment

Scout Groups are required to bring along their own tents, cooking and eating utensils, and personal gears for camp.

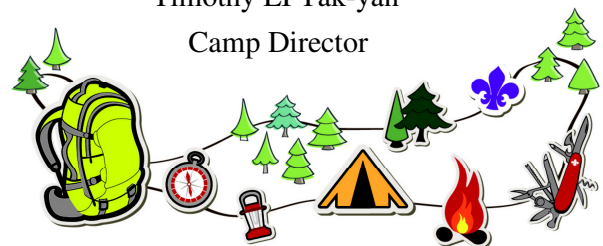

Scout Association of Hong Kong Hong Kong Scout Centenary Jamboree Registration Procedure

Eligibility

Campers of the Jamboree must be Scouts, Venture Scouts or Rover Scouts fulfilling all of the following criteria:

1. Aged between 12 and 26;
2. Campers who are under the age of 18, their parents' or guardians' approval must be sought;
3. Recommended by Group Scout Leader / Scouter-in-charge; and
4. The ratio of adult leader to youth member is 1: 9 (The ratio of 1: 9 does not apply to Rover Scouts. If no Rover Scout leader is available to take up the duty as a leader in the camp, Rover Scouts may submit their Registration Forms to their respective *Regions with support from Group Scout Leader / Scouter-in-charge.).

Registration Procedure

1. Each camper should register by completing the Registration Form, making sure that it has been signed by the camper himself/herself.
2. The duly completed form together with camp fee should be returned to the Scouter-in-charge for endorsement. For the payment made by cheque, please cross the cheque and make payable to "Scout Association of Hong Kong" **(with region name, Scout Group number, camper name and telephone number written at the back of the cheque).**
3. The Scouter-in-charge collects all Registration Forms and camp fees from members of his/her responsible Group, checks all parts of the forms have been completed before endorsing them.
4. The Scouter-in-charge banks in the camp fees into the designated bank account:

Please write the region name, Scout Group number, contact person name and telephone number at the back of the original pay-in-slip.

5. The Scouter-in-charge submits the Registration Forms to his/her respective *Regional Headquarters together with the original pay-in-slip. Please keep a photocopy of the pay-in-slip for recording purpose.
6. Staff at *Regional Headquarters checks whether the amount of camp fees being banked in is correct before issuing the Official Receipt to acknowledge receipt of camp fees.
7. In due course, the Scouter-in-charge receives a list of registration data for confirmation.
8. If discrepancy exists, the Scouter-in-charge informs the respective *Regional Headquarters immediately for clarification and amendment.
9. The *Regional Headquarters notifies the Scouter-in-charge for collection of camper handbook, scarf, cap, Jamboree emblem and name tag prior to the Jamboree.

Registration Deadline

1st Batch : 15 July 2010 (Applicants who enroll before the deadline of 1st Batch of registration will get an early bird souvenir badge)

2nd Batch : 15 October 2010

In view of the limited resources and camping area, the Organizing Committee will accept campers who have enrolled before the 1st batch registration deadline. The quota left will be filled up by the applicants at 2nd Batch.

Note

1. For campers not participating the whole duration of the Jamboree, they are still required to pay full fee.
2. Only one Official Receipt will be issued to each Group.
3. Refund for cancellation of registration will not be entertained under any circumstances. However, substitution of eligible participants is allowed. The Scouter-in-charge must notify the respective *Regional Headquarters of such substitution by 30 October 2010. Late application for swapping of campers will not be allowed after that date.
4. In addition to the personal health information stated in the Registration Form, campers may state on a separate sheet for any other health information, such as illnesses and allergies, and submit it together with the Registration Form.
