#### Application Procedure for Assessment of the Golden Bauhinia Award:

- (1) Aged 9.5 or over of Cub Scout and finished the Cub Scout Adventure Award.
- (2) Complete this form.
- (3) Submit the completed form together with a photocopy of the following documents to the District Office: information regarding personal details, scouting record, renewal of membership, membership badge, the assessment of the Cub Scout Award and the Cub Scout Adventure Award (i.e. Pages 1-3, 5 and 10-13 or 8-11) in the Cub Scout Record Book.
- (4) After approval by District Commissioner, respective District will pass a photocopy of this form and the Golden Bauhinia Award Assessment Record Book to the responsible leader.
- (5) The application can be submitted throughout the year.
